Purpose Statement: Old Town Art Gallery (OTAG) is a member only gallery with a mission to promote and support art in the community. It includes artists who work in a variety of mediums. The management and operation of the Gallery is guided by rules set up in the by-laws and standing rules. All members of the Gallery are working partners, sharing costs and labor involved in operating and maintaining a business.

Application Process: The prospective member shall submit five (5) pieces of artwork that are clean, framed and/or ready for display with the application to the membership at least two weeks prior to the monthly membership meeting (usually the second Thursday of every month). If the work appears to be compatible, an OTAG member will call the applicant for an interview by the Membership Committee. Acceptance of an applicant requires a two-thirds favorable vote of the membership. If there is no available opening at the time of application, the potential member shall be placed on a waiting list. The applicant will be notified of the membership's decision by phone or letter.

Membership Requirements:

1. Monthly membership dues is sixty dollars (\$60) with a 20% commission. Upon acceptance, a new member will pay the first and last month's dues plus a \$100 one-time application fee, all of which are non-refundable. There is a six (6) month commitment. A late fee of ten dollars (\$10) will be subjected by the tenth of the month and each month thereafter for a two (2) month period when membership will be reevaluated.
2. A minimum of two days of gallery sitting monthly is required depending on the current number of members.
3. All members are encouraged to attend monthly meetings and Arts Alive! the first Saturday of every month.
4. Residency in Humboldt County is required.

General Information:

1. Gallery space shall be divided proportionately amongst the membership. The Space Committee shall allocate the division of space. Rotation of artwork shall take place every two months, unless otherwise determined by the membership.
2. No pornographic material shall be accepted for gallery display. OTAG only exhibits artwork, which is done in good taste, and which meets the approval of the general viewing public as determined by the members. All artwork must present a professional level of execution.
3. Each member is expected to share in the general upkeep of the OTAG, such as vacuuming, dusting, emptying trash, cleaning the bathroom, keeping all areas in the storage room and kitchen neat and clean, etc., during scheduled sitting dates.
4. Professional behavior and ethics is required of all members when representing OTAG.
5. OTAG cannot take responsibility for loss due to fire, breakage or damage occurring to a piece of artwork while exhibited in the gallery.
6. Members shall comply with all rules governing the OTAG. If a member behaves inappropriately, is difficult to work with or does not hold up his/her part of the Membership Application/Artist's Agreement, membership may be revoked by a majority vote and notified by letter.

1. Having exposure of one's art for public viewing is the most obvious benefit. During the tourist season (May – December) we have 20-30 visitors a day.

4. Becoming a business owner of the oldest cooperative gallery in Humboldt County is a great learning experience and, because we are a non-profit corporation and pay sales tax each quarter:
 - a. Artists do not have to get a sales tax number (unless they sell outside of Old Town Art Gallery).
 - b. Individual members are **not** liable for any unpaid debts, should there ever be any.

Each member carries a part of the workload by spending two or three days a month working at the gallery. Members join in abiding by the bylaws as well as making friends for a lifetime.
